**Qualification of Operator Members.** *Any corporation, partnership or individual holder of a valid passenger bus operating certificate granted by the USDOT, Maryland PSC and/or the Washington Metropolitan Area Transit Commission who operates motor buses with a seating capacity greater than twenty-one (21) passengers, excluding the driver, other than buses designed and manufactured specifically for the transportation of school children traveling to and from school, shall be eligible for membership in this Corporation. Said operator members shall be entitled to all rights and privileges conferred hereunder. Corporate and partnership operator members may be represented by a shareholder, officer, director, or other designated representative of said member.*
